### **RESOLUTION 2017-02**

# A RESOLUTION OF THE BOARD OF SUPERVISORS OF THE CARLTON LAKES COMMUNITY DEVELOPMENT DISTRICT ALLOCATING A PORTION OF FUTURE BOND PROCEEDS TO FINANCE THE CONSTRUCTION AND ACQUISITION OF AN AMENITY CENTER; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Carlton Lakes Community Development District (the "District") previously indicated its intention to construct and/or acquire assessable improvements, including but not limited to, certain amenities, described in the Engineer's Report, dated October 2, 2015 (the "Improvements").

**WHEREAS**, the Board of Supervisors of the District (the "**Board**") intends to finance the Improvements through the issuance of one or more series of bonds, which bonds will be repaid by the imposition of special assessments on the benefited property within the District; and

WHEREAS, for the District's next bond issuance, anticipated to occur in 2017 ("2017 Bonds"), the Board desires to allocate \$2,000,000 of the bond proceeds to finance the construction and acquisition of an amenity center.

### NOW, THEREFORE, BE IT RESOLVED BY THE BOARD AS FOLLOWS:

- Section 1. Authority for this resolution. This Resolution is adopted pursuant to Chapters 170 and 190, Florida Statutes.
- Section 2. Allocation of a portion of the proceeds from 2017 Bonds. The District hereby directs its staff to include a specific subaccount in the supplemental trust indenture for the 2017 Bonds that allocates \$2,000,000 of the bond proceeds generated from the 2017 Bonds for the sole purpose of financing the construction and acquisition of an amenity center and other community amenities as shown on the Draft Amenity Plan attached as Exhibit "A".

Section 3. Effective date. This Resolution shall become effective upon its adoption.

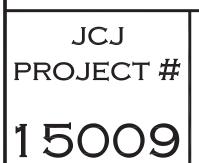
